## NORTHGATE RESORTS 2025 CAMP CREDIT GIVEAWAY

## **OFFICIAL RULES**

Entry into this Promotion constitutes your acceptance of these Official Rules.

- 1. SPONSOR: This 2025 Summer Camp Credit Giveaway ("Giveaway") is sponsored by Northgate Property Services, LLC, 38 Commerce Ave. SW, Suite 200, Grand Rapids, MI 49503 ("Northgate"), and its Affiliated Participating Resorts ("Participating Resorts") more particularly described in Section 18 (collectively hereinafter, "Sponsors").
- 2. WHO IS ELIGIBLE: The Giveaway is only open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia, excluding residents of Puerto Rico, all U.S. territories and possessions and all overseas military installations, who are at least twenty-one (21) years of age at the time of entry. ("Entrant"). Employees of Sponsors, affiliates, subsidiaries, directors, officers and voucher suppliers (collectively, the "Giveaway Entities"), and each of their immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to enter or win. For the purpose of the Giveaway, family members are defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren. Void where prohibited by law. Limit one (1) entry per person during the Entry Period (defined below). Entries that are unidentifiable, incomplete, illegible, corrupted, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules (defined below) may be disqualified from the Giveaway at the Sponsors' sole and absolute discretion. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to the Sponsors' satisfaction, the affected entry will be deemed ineligible. The website clock for the Social Media Pages (defined in section 4) will be the official timekeeper for this Giveaway. Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.
- **3. ENTRY PERIOD**: The Giveaway begins at 7:00 a.m. Eastern Standard Time ("EST") on June 5, 2025 and expires at 11:59 p.m. EST on September 8, 2025 ("Entry Period").
- **4. HOW TO ENTER**: This Giveaway is limited to past customers of Participating Resorts that made a minimum of one (1) booking reservation between May 23, 2025, and September 1, 2025 ("Qualified Customers"). To officially be entered in the Giveaway, Qualified Customers will receive an email invitation to the email address associated with their reservation, inviting them to leave a review of their resort experience ("**Review**") on any of its three (3) social media websites: (1) Google Review web page; (2) Facebook web page; or (3) Yelp web page, collectively social media pages ("**Social Media Pages**"). Qualified Customers that complete a customer

Review on any of the Social Media Pages for the Participating Resort at which they stayed, will be entered in the Giveaway ("Eligible Entry").

The content of your review - whether positive, negative, or neutral - will not influence your chances of winning; all eligible reviews will be considered equally for entry.

While this Giveaway is limited to past customers of Participating Resorts who made a booking reservation between May 23, 2025, and September 1, 2025, an alternative method of entry is available for those who do not wish to leave a review. To enter without leaving a review, Qualified Customers may send a written request with their full name, email address, phone number, and the name of the Participating Resort they stayed at to 38 Commerce Ave SW, STE 200, Grand Rapids, MI 49503. All entries received through this alternative method will have an equal chance of winning as those submitted via a review on the Social Media Pages.

In the event of a dispute over the identity of an Entrant, entry will be deemed submitted by the authorized account holder of the Review entry. "Authorized Account Holder" is defined as the natural person who is assigned a user account by either of the email provider and/or social media platforms (Google, Facebook, or Yelp associated with the Social Media Pages.)

- **5. BINDING AGREEMENT**. In order to participate in the Giveaway or to win a Voucher, Entrant must agree to these Official Rules ("Official Rules"). Because these Official Rules form a legally binding agreement with respect to the Giveaway, please read them carefully. If Entrant does not agree to the Official Rules, Entrant is not eligible to participate in the Giveaway or to win any of the Vouchers. Entrant agrees that his/her registration as an individual participant under the Giveaway constitutes his/her agreement to these Official Rules.
- 6. WINNER SELECTION/NOTIFICATION. One (1) Winner will be selected by a random drawing from all Eligible Entries within five (5) days of the conclusion of the Entry Period. The Sponsor and/or Administrator will notify the Winner via email, using the email address associated with their reservation, regarding their selection as the Winner of the 2025 Camp Credit Giveaway. The Winner must respond to the initial email notification, following the instructions provided, within five (5) business days. Failure to do so may result in forfeiture of the Voucher, which may then be awarded to an alternate Entrant. No liability is assumed for any winner notification that is lost, intercepted, or not received by the potential Winner for any reason.
- **7. VOUCHERS:** A total of \$500 in Camp Credit, ("**Voucher**") to be applied to any future reservation at the respective Participating Resort. Voucher may only be redeemed for a future stay and cannot be applied to any existing reservation.

The Voucher must be used within one (1) year following the Giveaway end period. The Voucher is non-transferable, with no cash redemption, equivalents or substitutions except at the Sponsors' sole and absolute discretion. Any dispute as to

the correct person to receive the Vouchers will be decided by the Sponsors at their sole discretion. Winner is responsible for all costs and expenses not set forth herein, as well as any federal, state, and/or local taxes imposed as a result of acceptance of Vouchers.
